# CHINA CENTER FOR HUMAN CAPITAL AND LABOR MARKET RESEARCH (CHLR)

Established in March 2008, the China Center for Human Capital and Labor Market Research (CHLR) at the Central University of Finance and Economics (CUFE) is part of Special Platform for Advance Programs at the CUFE. It is an international research center for the study of human resources, labor markets, and their impact, focusing on China and related economies.

Nobel Laureates James Heckman, and Professor Dale W. Jorgenson of the Harvard University and the founder of the income-based method for measuring human capital, serve on the Advisory Board.

All faculty and research fellows of the CHLR hold a Ph.D. degree in economics from major universities in North America and Europe, and all visiting professors are tenured professors from major U.S. universities. Currently the Center has 1 "Changjiang Fellowship" Scholar, 6 full-time faculty members, 7 special term professors, 11 senior research fellows.

The major research areas in the Center include but are not limited to human capital investment, measurement, and impact; education, health; innovation, entrepreneurship; and labor market and policy.

The CHLR has master's, doctoral and post-doctoral programs. The Center's graduate programs are internationally oriented. The curriculum and instruction are rigorously designed following research universities in North America. All courses are taught in English.

# 中央财经大学 中国人力资本与劳动经济研究中心简介

中国人力资本与劳动经济研究中心(CHLR)(以下简称"中心")隶属于中央财经大学"经济学与公共政策优势学科创新平台",成立于 2008 年 3 月,是一个以研究中国人力资本、劳动力市场及其与经济发展关系为主要研究方向的院级国际化研究中心;中心招收博士后、博士和硕士研究生。中心顾问由该领域的国际著名教授担任,其中包括诺贝尔经济学奖得主 James Heckman 教授,以及人力资本计算方法——终身收入法创始人之一,哈佛大学的 Dale W. Jorgenson教授。

中心以科研为主导,强调国际化的前沿学术研究。主要研究方向为: 1)人力资本的形成、度量及作用,2)教育、健康与人力资本,3)人力资本与创新及创业,4)劳动力市场与政策,5)人口与社会保障,6)产业组织。

中心的教学科研成员全部为北美知名高校的终身教授或者拥有北美或欧洲知名高校经济学博士学位的海归学者。中心有教育部"长江学者"特聘教授 1 人,全职教师 6 人,特聘教授 6 人及特聘研究员 11 人。教师队伍中,特聘教授 7 人,副教授 1 人,助理教授 5 人。

中心拥有科学完备的博士及硕士研究生培养方案,其课程体系和课程设置与 美国研究类高校一致,采用全英文授课及国际化人才培养方式。截至 2017 年, 中心已毕业博士后 1 人,博士生 8 人,硕士生 91 人。目前在校生 35 人,其中全 日制硕士生 32 人,全日制博士生 3 人。

# BRIEF INTRODUCTION TO THE CHINA'S HUMAN CAPITAL PROJECT

The research project, "China's Human Capital: Measurement and Index Construction," is conducted by the China Center for Human Capital and Labor Research Center (CHLR), and funded by the National Natural Science Foundation of China and the Central University of Finance and Economics. The project aims at establishing China's first scientific and systematic human capital index, quantitatively describing China's human capital distribution, trend and dynamics. It constructs important measurements for further evaluating human capital and its contribution to economic development, and provides policy-makers with important information on the nation's human capital development.

The project is part of the international effort to establish comparable national human capital measurement across nations and to eventually incorporate human capital into the National Income and Product Accounts (NIPA) system.

The project is led by Professor Haizheng Li. The research team includes Professor Barbara Fraumeni (a pioneer scholar in developing the Jorgenson-Fraumeni method of human capital calculation), other full-time and special-term professors, graduate students, and administrative staff at the CHLR. Since the inaugural issue of the China Human Capital Report in 2009, the project has generated great social impact, and drawn the attention of academia and governments both at home and abroad.

The human capital measurements from this project have been widely used in research and policy analysis. The China human capital report series and the related data including the human capital estimates, processed data and raw data, are freely available for public at http://humancapital.cufe.edu.cn/

### 中国人力资本指数项目简介

中国人力资本与劳动经济研究中心(以下简称"中心")的"中国人力资本的测量及人力资本指标体系的构建"项目得到国家自然科学基金委员会连续九年的资助及中央财经大学的专项资助。该项目旨在建立中国第一套科学、系统的人力资本指数,定量描述中国人力资本的分布及发展动态;为更深入地研究人力资本在中国经济发展中的作用提供综合的度量指标;在实践上为政府的相关重大经济社会决策提供定量依据;同时也为中国的人力资本度量方法和指标成为国际人力资本指标体系的一部分、为人力资本作为国民账户的一部分纳入到我国国民财富的衡量体系提供前期工作。该项目由中心李海峥教授主持,由人力资本收入计算法(Jorgenson-Fraumeni 方法)创始人之一的 Barbara Fraumeni 教授,中心全职教授和特聘教授,以及中心全体博士、硕士研究生及行政人员共同参与。

研究成果汇编成的《中国人力资本报告》自 2009 年公开发布以来,受到了国际、国内学术界及我国政府部门的高度重视,引起了广泛的、良好的社会反响。

中国人力资本报告系列及历年的计算结果、中间数据、以及原始数据已经被 广泛应用,相关资料及数据可以在人力资本中心官方网站下载,免费供社会各界 使用(http://humancapital.cufe.edu.cn/)。

### 2009--The First International Symposium on Human Capital and Labor Markets

About the Symposium

On October 10, 2009, CHLR held its first international symposium on measurement of human capital and released the first China Human Capital Report 2009. The Principle Investigator for the project, Prof. Haizheng Li presented the methodology of the estimation of human capital stock and the estimation results at the national level for 1985-2007. The China Human Capital Report 2009 establishes China's first systematic and comprehensive human capital measurement and human capital index, including the stock of human capital of China 1985-2007, by urban-rural and by gender; human capital per capita; and various human capital indices; and the forecast of China's human capital stock for 2008-2020. The symposium included academic sessions focusing on the measurement of human capital, construction of the human capital index, and the contributions of human capital to economic growth and welfare.

#### **Participants**

Nobel Laureate Prof. Kenneth J. Arrow, Prof. Ken He (Deputy Director, Finance Committee of the Standing Committee of the National People's Congress), and Prof. Dale W. Jorgenson (co-founder of the Jorgenson-Fraumeni income-based method for measuring human capital, Harvard University), gave keynote speeches in the plenary session. Prof. Guangqian Wang (President of CUFE), Prof. Donggang Zhang (Deputy Director of the Social Science Division, Ministry of Education), Dr. Xianchun Xu (Deputy Commissioner, National Statistics Bureau), Dr. Zhongjie Jia (Director of the Senior Civil Servants Training Center, Ministry of Human Resources and Social Security) also participated in the symposium. Over 800 domestic and foreign scholars including Professor Barbara M. Fraumeni (University of Southern Maine), national and international government officials, as well as university students, attended the symposium.

### 2010--The Second International Symposium on Human Capital and Labor Markets

About the Symposium

The Second International Symposium on Human Capital and Labor Markets and the release of the China Human Capital Report 2010 was held in Beijing October 15, 2010. The symposium was organized by the CHLR. In the meeting, the China Human Capital Index and Report 2010 were released. This year's report updates the human capital estimation at the national level; and for the first time, human capital at the provincial level is estimated. The 2010 report includes human capital estimation results for Beijing, Liaoning, Jiangsu, Guangdong, and Gansu.

#### **Participants**

Dr. Ardo Hansson (Chief Economist, World Bank China Office), Dr. Danling Zhao (Official of Ministry of Education), Prof. Yuetian Li (Deputy Director-General

of Ministry of Human Resources and Social Security), and Prof. Guoqiang Long (Director-General, Research Department of Foreign Economic Relations, the State Council Research and Development Center) provided helpful comments on the human capital index report, as specially invited discussants. Prof. Barbara Fraumeni (a co-developer of the Jorgenson-Fraumeni method of human capital calculation) chaired the meeting, and Professor Haizheng Li presented new results from the Human Capital Report 2010. Additionally, officials from the Ministry of Education, National Development and Reform Commission, the National Bureau of Statistics, the Department of Organization of Beijing, and the Development and Reform Commission of Shanghai, and other agencies, as well as domestic and foreign scholars attended the symposium.

### 2011--The Third International Symposium on Human Capital and Labor Markets

About the Symposium

The Third International Symposium on Human Capital and Labor Markets and the release of the China Human Capital Report 2011 was held in the Central University of Finance and Economics (CUFE) on October 28, 2011. The symposium was organized by the CHLR, and it released the China Human Capital Report 2011. Compared with previous human capital reports, the 2011 Report shows significant improvements in calculations methods, addresses the problem of missing data at the provincial level, and also adds new micro survey data. The Report updates the national human capital estimates for 1985-2009 and expands the coverage of provinces to 12 provinces (Beijing, Shanghai, Gansu, Guangdong, Jiangsu, Liaoning, Anhui, Shandong, Guizhou, Hubei, Hunan, and Henan). In addition, the Report discusses human capital across provinces and their trends and patterns.

#### **Participants**

Specially invited discussants and commentators, Desheng Lai (Dean, Beijing Normal University), Yang Du (Fellow, Institute of Labor and Population Economics, Chinese Academy of Social Sciences), Zhaoming Gui (Professor, Wuhan Institute of Technology), Yongzhi Liu (Director, China Association of International Exchange of Personnel), Philip O'Keefe (Lead Economist, World Bank) gave in-depth discussions on this year's Report. Mr. Fengyun Lei (Deputy Director, State Administration of Foreign Experts Affairs), Prof. Barbara Fraumeni (a co-developer of the Jorgenson-Fraumeni method of human capital calculation), Prof. Yijun Li (Deputy Director, Division of Management Science, National Natural Science Foundation of China), Junsheng Li (Vice President, Central University of Finance and Economics), as well as other domestic and foreign scholars also attended the symposium.

### 2012--The Fourth International Symposium on Human Capital and Labor Markets

About the symposium

The Fourth International Symposium on Human Capital and Labor Markets celebrating release of the China Human Capital Report 2012, organized by the CHLR was held in CUFE on December 14, 2012. The China human capital report 2012 was released. The new report uses updated provincial statistical data and computes human capital for five new provinces (Tianjin, Heilongjiang, Zhejiang, Guangxi and Shaanxi) in 1985-2009. The corresponding panel data of measures of human capital for 17

provinces was constructed. Various data of human capital were released online at the Center's website to promote sharing of research data.

#### **Participants**

Prof. Barbara Fraumeni (University of Southern Maine, a co-developer of the Jorgenson-Fraumeni method of human capital calculation) chaired the plenary session. The new human capital report was presented by Prof. Haizheng Li. As specially invited discussants and commentators, Prof. Weiping Li (the chief research fellow from the Chinese Academy of Personnel Science), Prof. Dennis Tao Yang (University of Virginia), and Prof. Yansui Yang (Tsinghua University), gave insightful comments on the Report. In the afternoon, the conference organized three academic sessions. Scholars from China and other countries discussed ongoing research related to broad issues of human capital and labor markets. Prof. Rachel Connelly (Bowdoin College), Prof. Zhenhui Xu (Georgia University and College), and Prof. Dennis Tao Yang chaired the academic sessions. Prof. Lifen Zhao (Vice President of CUFE) also attended the symposium.

### 2013--The Fifth International Symposium on Human Capital and Labor Markets

About the symposium

The Fifth International Symposium on Human Capital and Labor Markets celebrating release of the China Human Capital Report 2013, organized by the CHLR was held in CUFE on December 15, 2013. The China human capital report 2013 was released. Updated national and provincial human capital using newly released 2010 census data. Estimated human capital for 5 new provinces in 1985-2010: Hainan, Jiangxi, Jilin, Sichuan, Chongqing. The corresponding panel data of gross measures of human capital for 22 provinces was constructed. Estimated and reported national and provincial physical capital stock. Estimated and reported cross-provincial living cost.

#### **Participants**

Prof. Barbara Fraumeni (University of Southern Maine, one of the founders of the Jorgenson-Fraumeni method of human capital calculation) chaired the plenary session. The new human capital report was presented by Prof. Haizheng Li. As special invited keynote speakers, Prof. Zhenghua Jiang (former vice chairman of the National People's Congress), Prof. Mark R. Rosenzweig (Frank Altschul Professor of Economics, Yale University) gave keynote speeches. Dr. Vincent Perrin (OECD Beijing Representative), Prof. Belton M. Fleisher (Editor of China Economic Review & Ohio State University & CHLR), Prof. Guangqian Wang (president, CUFE), Prof. Junsheng Li (Vice President of CUFE), Prof. Lifen Zhao (Vice President of CUFE) also attended the symposium.

In the afternoon, the conference organized parallel academic sessions. Scholars from China and other countries discussed ongoing research related to broad issues of human capital and labor markets. There are 41 research papers selected from international and domestic submissions, and 10 human capital-related parallel sessions are organized..

### 2014--The Sixth International Symposium on Human Capital and Labor Markets

About the symposium

The sixth International Symposium on Human Capital and Labor Markets celebrating release of the China Human Capital Report 2014, organized by the CHLR was held in CUFE on October 31, 2014. The China human capital report 2014 was released. Estimated human capital for 9 new provinces in 1985-2010: Shanxi, Qinghai, Inner Mongolia, Xinjiang, Tibet, Yunnan, Fujian, Hebei, Ningxia, Hong Kong and Taiwan. Re-estimated human capital for Hainan province. Estimated and reported national and provincial physical capital stock. Estimated and reported cross-provincial living cost.

#### **Participants**

Jeffrey S. Zax (Professor, University of Colorado at Boulder) chaired the plenary session. Belton M. Fleisher (Professor, Ohio State University & Special-term Professor, CHLR & Editor, China Economic Review) gave a speech on "Remarks in Memory of Gary S. Becker." The new human capital report was presented by Haizheng Li (Professor, Georgia Institute of Technology & CHLR), Barbara Fraumeni (Professor, University of Southern Maine & CHLR, one of the founders of the Jorgenson-Fraumeni method of human capital calculation) and Carsten A. Holz (Professor, Hong Kong University of Science and Technology & CHLR). Specially invited discussants and commentators, Shujie Han (Editorial Director, Journal of Human Resource Development of China), Martina Lubyova (Director, Institute for Forecasting, Slovak Academy of Sciences), Peter F. Orazem (Professor, Iowa State University) and Jeffrey S. Zax (Professor, University of Colorado at Boulder) gave in-depth discussions on this year's Report. Prof. Junsheng Li (Vice President of CUFE) also attended.

We received 77 submissions, among which 32 are accepted for presentation.

### 2015--The Seven International Symposium on Human Capital and Labor Markets

#### About the symposium

The seventh International Symposium on Human Capital and Labor Markets celebrating release of the China Human Capital Report 2015, organized by the CHLR was held in CUFE on December 12, 2015. The China human capital report 2015 was released. Human capital calculation for all provinces, autonomous regions, municipalities and special administrative regions (excluding Macao) has been extended to 1985-2012. There are some revisions and improvements in the 2015 Report, like updating the data set of enrollment categorized by region and gender to 1985-2012, adding China Family Panel Studies (CFPS2011) to estimate Mincer parameters and so on. The China Human Capital Report 2015 also reports the average age of labor force, average education level and the proportion of high-school education. The news of establishing CPS (Complex Problem Solving) Test Lab in China by the CHLR was released during the symposium.

#### **Participants**

Belton M. Fleisher (Professor, Ohio State University & Special-term Professor, CHLR & Editor, *China Economic Review*) chaired the plenary session. The new human capital report was presented by Haizheng Li (Professor, Georgia Institute of Technology & CHLR), Barbara Fraumeni (Professor, University of Southern Maine & CHLR, one of the founders of the Jorgenson- Fraumeni method of human capital calculation) and Carsten A Holz (Professor, Hong Kong University of Science and Technology & CHLR). Specially invited discussants and commentators are: Gary Jefferson (Professor, Brandeis University), Scott D. Rozelle (Professor, Stanford

University), Shi Li (Professor, Beijing Normal University) and Tao Xin (Professor, Beijing Normal University). Phil. Samuel Greiff (Associate Professor, University of Luxembourg), Kevin Murphy (Professor, Colorado State University) and Peer Ederer (Professor, Zeppelin University) participated in the releasing the news of establishing CPS. Jianfeng Peng (Professor, Renmin University & Chairman, China Stone) and Jianping Shi (Vice President of CUFE) also attended.

More than one hundred of international and domestic scholars attended the seventh human capital conference. The symposium selected 40 papers out of 98 submissions, with 10 parallel sessions covering education, income, health, poverty and behavior, labor market, employment, immigration, human capital, children and complex skills.

### 2016--The Eight International Symposium on Human Capital and Labor Markets

About the symposium

The eighth International Symposium on Human Capital and Labor Markets celebrating release of the China Human Capital Report 2016, organized by the CHLR was held in CUFE on December 10, 2016. The China human capital report 2016 was released. Human capital calculation for all provinces, autonomous regions, municipalities and special administrative regions (excluding Macao) has been extended to 1985-2014. There are some revisions and improvements in the 2016 Report, like updating the data on school enrollment by region and gender based on new data sources for 1985-2014, estimating both national and provincial physical capital stock for 1985-2014 and so on. The China Human Capital Report 2016 also unified population estimation method at the national and province level, and re-calculated national human capital.

#### **Participants**

Belton M. Fleisher (Professor, Ohio State University & Special-term Professor, CHLR & Editor, *China Economic Review*) chaired the plenary session. The new human capital report was presented by Haizheng Li (Professor, Georgia Institute of Technology & CHLR), Barbara Fraumeni (Professor, University of Southern Maine & CHLR, one of the founders of the Jorgenson- Fraumeni method of human capital calculation) and Carsten A Holz (Professor, Hong Kong University of Science and Technology & CHLR). Specially invited discussants and commentators, *Min Tang* (Ph. D, State Department Counselor & Vice President of YouChange China Social Entrepreneur Foundation), *Boqing Wang* (Ph. D, Founder & Chair of MyCOS (China Occupational Skills)) gave in-depth discussions on this year's Report. Jianping Shi (Vice President of CUFE) also attended.

We received 122 submissions, among which 60 papers accepted for presentation in 14 parallel sessions.

### 历届中国人力资本指数发布暨人力资本研讨会回顾

#### 一、第一届人力资本研讨会

#### 1. 会议内容

2009年10月10日,中央财经大学中国人力资本与劳动经济研究中心举办了主题为"人力资本的度量及其对增长和福利的贡献"国际研讨会,首次发布中国国家层面人力资本指数及《中国人力资本报告2009》(中英文版)。项目负责人李海峥教授详细阐述了中国人力资本度量方法与相应的计算结果,以及中国人力资本度量项目的未来发展方向。

本项目探索性地建立了中国人力资本的综合度量体系,其阶段性成果包括: 1985-2007 年中国分城乡、分性别的名义与实际人力资本存量,相应人均人力资本与各种人力资本指数;人力资本分布状况和变化趋势;对 2008-2020 年中国人力资本水平的预测。

本次会议还组织了学术分会,分会主题包括人力资本度量方法、中国人力资本指数的构建、以及人力资本对经济增长和福利的贡献等。

#### 2. 出席嘉宾

诺贝尔经济学奖获得者肯尼斯·阿罗(Kenneth Arrow)教授、全国人大常委财经委员会副主任贺铿教授、人力资本计算方法创始人哈佛大学的戴尔·乔根森(Dale Jorgenson)教授分别作大会主题发言。中央财经大学校长王广谦教授,教育部社科司副司长张东刚,国家统计局副局长许宪春,人力资源和社会保障部、中国高级公务员培训中心主任贾忠杰等以及其他海内外政府官员和学者出席了会议。来自海内外的专家学者、政府及国际组织官员、高校学生等八百多人参加了全体会议。

#### 二、第二届人力资本研讨会

#### 1. 会议内容

2010年10月15日,中央财经大学中国人力资本与劳动经济研究中心举办了"第二届中国人力资本指数发布暨人力资本研讨会",本次会议发布了《中国人力资本报告2010》,内容包括:更新后的中国国家层面人力资本计算结果,并首次将中国人力资本的计算深入到省级层面,计算1985-2009年北京、甘肃、广东、江苏、辽宁五个省(市)的人力资本存量与指数。

#### 2. 出席嘉宾

世界银行驻华首席经济学家 Ardo Hansson 博士,教育部人事司副巡视员赵丹玲、人力资源和社会保障部政策研究司副司长李月田、国务院发展研究中心对外经济研究部部长隆国强等应邀对人力资本报告进行点评。人力资本终生收入法的创始人之一 Barbara Fraumeni 教授组织本次人力资本报告的发布和点评。此

外,教育部、国家发改委、国务院发展研究中心、人力资源和社会保障部、财政部、科技部、国家统计局、北京市组织部、上海市发改委的领导及其他国内外专家学者出席本次会议。

#### 三、第三届人力资本研讨会

#### 1. 会议内容

2011年10月28日,中央财经大学中国人力资本与劳动经济研究中心组织召开了"第三届人力资本国际研讨会暨2011年中国人力资本报告发布会",发布2011年中国人力资本指数和报告。与前两年的人力资本报告相比,《中国人力资本报告 2011》大幅度改进了计算方法以弥补省级数据的缺失,同时增加了微观调查数据,更新了1985-2009年国家层面人力资本指数并将省级层面估算扩展到12个省份:包括北京、甘肃、广东、江苏、辽宁、上海、安徽、山东、贵州、湖北、湖南和河南,并对各省人力资本分布和动态发展情况做出分析。

#### 2. 出席嘉宾

人力资本终生收入法的创始人之一 Barbara Fraumeni 教授、世界银行驻华主任经济学家 Philip O' Keefe 博士、欧洲人力资本项目负责人 Peer Ederer教授出席,北京师范大学经济与工商管理学院院长赖德胜教授、中国社会科学院人口与劳动经济研究所都阳教授、武汉工程大学管理学院桂昭明教授应邀作为点评专家,围绕本年度人力资本报告进行了深入讨论。国家外国专家局科教文卫司副司长雷风云、国家自然科学基金委员会管理科学部主任李一军、中央财经大学副校长李俊生等以及其他国内外专家学者前来参会。

#### 四、第四届人力资本研讨会

#### 1. 会议内容






